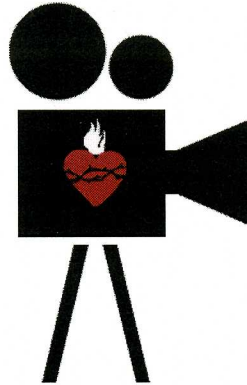

Conditions of Entry

- Agree to comply with these official rules.
